

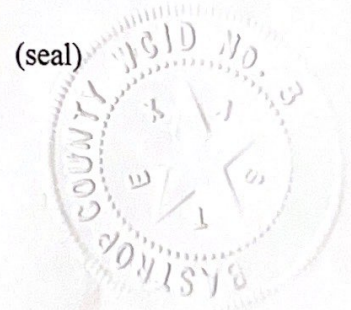

Whereupon, among other business, the following was transacted at the meeting: a written





ORDER CANCELLING THE DIRECTORS' ELECTION SCHEDULED FOR NOVEMBER 8, 2022; DECLARING THE UNOPPOSED CANDIDATES FOR DIRECTOR ELECTED; ORDERING POSTING OF NOTICE OF CANCELLATION IN ACCORDANCE WITH THE TEXAS ELECTION CODE; PROVIDING AN EFFECTIVE DATE; PROVIDING FOR A SAVINGS CLAUSE AND REPEALING CONFLICTING ORDERS AND RESOLUTIONS

WHEREAS, Section 49.103 of the Texas Water Code requires that elections for members of the board of a district shall be held on the uniform election date established by the Election Code in even-numbered years; and

WHEREAS, on August 15, 2022, the Board of Directors of the Bastrop County Water Control and Improvement District No. 3 (the "District") ordered an election to be held on Tuesday, November 8, 2022 for the purpose of electing directors for the positions currently held by Sharon Morris, Elizabeth Endres, and Rebecca Saenz; and

WHEREAS, notice of said election was duly posted and applications for candidates to file for a place on the ballot were received by the District's elections agent from July 23, 2022 through August 22, 2022; and

WHEREAS, declarations of write-in candidacy were received by the District's elections agent from July 23, 2022 through August 26, 2022; and

WHEREAS, the Secretary of the Board of Directors has certified in writing that the candidates for the Director positions currently held by Sharon Morris, Elizabeth Endres, and Rebecca Saenz are unopposed and that no person has filed a declaration of write-in candidacy for election to the Director positions currently held by Sharon Morris, Elizabeth Endres, and Rebecca Saenz; and

WHEREAS, Sections 2.051-2.054 of the Texas Election Code establish a procedure for declaring unopposed candidates elected to office without holding the election; and

WHEREAS, there is no proposition appearing on the ballot;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE BASTROP COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NO. 3:

Section 1: The matters and facts set out in the preamble of this order are hereby found and declared to be true and complete.

Section 2: The Board of Directors of the Bastrop County Water Control and Improvement District No. 3 accepts the Certification of Unopposed Candidates presented by the Secretary of the Board of Directors and dated August 26, 2022.

Section 3: Sharon Morris is hereby declared a duly elected Director on the Board of Directors to serve a four-year term of office, subject to issuance of Certificates of Election; her signing of the Statement of Elected Officer; the taking of her Oath of Office after the November 8, 2022 election date and no earlier than November 11, 2022, the first day of the period for the official canvass, and filing her bond as required by law.

Section 4: Elizabeth Endres is hereby declared a duly elected Director on the Board of Directors to serve a four-year term of office, subject to issuance of Certificates of Election; her signing of the Statement of Elected Officer; the taking of her Oath of Office after the November 8, 2022 election date and no earlier than November 11, 2022, the first day of the period for the official canvass, and filing her bond as required by law.

Section 5: Rebecca Saenz is hereby declared a duly elected Director on the Board of Directors to serve a four-year term of office, subject to issuance of Certificates of Election; her signing of the Statement of Elected Officer; the taking of her Oath of Office after the November 8, 2022 election date and no earlier than November 11, 2022, the first day of the period for the official canvass, and filing her bond as required by law.

Section 6: In accordance with Section 2.051 of the Texas Election Code, the election of directors for the positions currently held by Sharon Morris, Elizabeth Endres, and Rebecca Saenz of the District called for November 8, 2022 shall not be held.

Section 7: The Secretary of the Board, or her designee, is hereby directed to cause a copy of the Order of Cancellation attached hereto and incorporated by reference, at the polling place that would have been used in the election on November 8, 2022.

Section 8: After November 11, 2022, a Certificate of Election shall be issued to the above named unopposed candidates in the same manner as provided for candidates elected at the election.

Section 9: The Board approves the cancellation of any election services contract or joint elections contracts previously executed between the District and Bastrop County, Texas (the "County") and any other political subdivision to conduct voting on the date of the Election and to perform certain election services for the District in connection with the Election including certain of the supervisory and administrative duties relating to the conduct of the Election, and authorizes staff to undertake any actions necessary to effectuate the termination of said contracts.

Section 10: This order shall take effect immediately upon its adoption.

Section 11: If any provision, section, subsection, sentence, clause or phrase of this Order, or the application of same to any person or set of circumstances is for any reason held to be unconstitutional, void, invalid, or unenforceable, neither the remaining portions of this Order nor their application to other persons or sets of circumstances shall be affected thereby, it being the intent of the Board in adopting this Order that no portion hereof or provision or regulation contained herein shall become inoperative or fail by reason of any unconstitutionality, voidness, invalidity or unenforceability of any other portion hereof, and all provisions of this Order are declared to be severable for that purpose.

Section 12: This order shall be cumulative of all provisions of the orders and resolutions of the Bastrop County Water Control and Improvement District No. 3. All provisions of the orders and resolutions of the Bastrop County Water Control and Improvement District No. 3 in conflict with this order by the same are hereby repealed and all other provisions of the orders and resolutions of the District not in conflict with the provisions of this order shall remain in full force and effect.

Section 13: If is further found and determined that notice of the date, place, and subject of this meeting was posted in accordance with the terms and provisions of the Texas Government Code, Chapter 551 at least 72 hours preceding the scheduled time of this meeting and that the District has complied with the terms and provisions of said Chapter 551 of the Texas Government Code.
